# **CLUB LIQUOR LICENCE APPLICATION**

Over the course of 2020 the Committee has invested significant time and effort to now be in a position to make an Application to Consumer & Business Services for a Club Licence under the Liquor Licensing Act. This Licence will allow the Club to sell liquor for consumption on the premises.

The Committee has secured the Consent of the Council to the Club making this Application and the Council has completed a capacity assessment which imposes limits on the number of people that the Club can host due to its facilities. This assessment has determined that the Club can host a maximum of 120 male patrons and 120 female patrons when liquor is being sold.

A floor plan of the venue detailing where liquor will be consumed has been prepared and limits the consumption of liquor to the shed area where social gatherings occur. No liquor will be permitted in the court area of the Club.

The Council's Consent and capacity assessment together with the floor plan, details of all Committee members, Constitution and Licence Agreement must all be submitted as part of the Application. Our Licence Agreement with the Council for the next 5 years has only been finalised in the last few weeks.

As part of our Application we will nominate 3 people as a "responsible person" and no liquor can be sold at the Club unless one of these people are present and displaying their Liquor Licensing badge and ID. David Lowe, Tony Stacey and Harry Hatsitsopanidis have agreed to be a "responsible person".

The Club can appoint any number of people to serve or sell liquor but only people that have completed the Responsible Service of Alcohol (RSA) training. There are already a number of Club members that have completed this training.

The Committee has now obtained legal assistance to review all of the collated information and make the Application on behalf of the Club. We are advised that once the Application is lodged the Club will receive a hearing date for its Application and be notified of advertising requirements leading into the hearing date.

These advertising requirements will include having notices up around the Club and out at street level for a certain period of time advising affected parties of the Club's intention to seek a Liquor Licence. Affected parties do have the ability to object via a formal process and should objections be received by Consumer and Business Services, our hearing date could be delayed whilst these objections are dealt with.

The advertising requirements are very strict and must be displayed at all times. If notices are vandalised, knocked down or removed our advertising period can be reset and our hearing date could be delayed. The Committee would like the support of all members to monitor the notices around the Club and if there are any concerns please report them to David Lowe.

Holding a Liquor Licence comes with significant management, reporting and liability issues which fall on the Committee. The support of all Club members is required to support the Committee with all aspects of holding a Liquor Licence.

The Committee would like to appoint a person to keep records of members who have completed the RSA training, ensure that all required signage is displayed in and around the Club and generally report to the Committee on all matters relating to the Liquor Licence operations. If you would be prepared to assist with these obligations please speak with David Lowe.
